**RE: Unofficial Report - 5th District - November 6 Special Congressional

Listed below are the instructions for reporting the unofficial results for the 5th Congressional District Special Congressional Primary Election held on November 6, 2007.

On election night:

1. As noted in the Election Night electronic mail message sent by Traci Washington on October 18, 2007, each county board of elections in the 5th Congressional district must report Congressional election results electronically to the Secretary of State's office using the instructions provided in the e-mail. If you have any questions concerning the election night reporting process to the Secretary of State's office, please contact Traci at 614-466-2585 or via e-mail at twashing@sos.state.oh.us.
2. If, due to technical difficulties, your board is unable to report Congressional election results electronically, please use the attached **SOS Election Night Reporting System Form** and **Fax Reporting Instructions Sheet** to fax your results to the Secretary of State's office on election night.

NOTE: Before you leave the board office on election night, please report your final Congressional election results to the Wood County Board of Elections, the most populous county for the 5th Congressional District, via e-mail at wood@sos.state.oh.us; or fax the form to Wood County BOE at 419-354-1730.

FAX REPORTING INSTRUCTIONS for:

Ashland, Crawford, Defiance, Fulton, Henry, Huron, Lucas and Mercer Counties

All counties are required to return their election night reports electronically.

If for any reason you are unable to transmit electronically, please complete the attached "Election Night Reporting System Form" and follow the fax reporting instructions listed below. (Please notify our office prior to faxing at 614-466-2585)

FAX REPORTING INSTRUCTIONS

Your county's reporting fax number is: 614-485-7574

Include on **EACH** report page:

1. Number of precincts reporting
2. Be sure to indicate whether it is a partial or *final report. If final, please see special instructions below.

First report: If your county maintains an absentee precinct for tabulation purposes, report those results immediately after the polls close; *otherwise, please fax the SOS Election Night Reporting System Form when the first ten precincts have reported.*

Frequency of fax reports: Report results every hour thereafter. Be sure to include previously reported results so that each report is cumulative. If we do not receive timely results, we will call your board for your results and an explanation for your non-reporting.

***FINAL REPORT:** When all of your precincts have reported, please report the total number of persons voting in the Special Congressional Primary Election on your final fax. Your report will not be considered to be final until we have results for all Congressional candidates, the total number of persons voting on the congressional races, and the total of outstanding absentee and provisional ballots.

SPECIAL NOTE: If you experience problems in faxing to the above number, please use alternate fax numbers of 614-752-4360 or 614-995-5395. Please include a cover sheet with your first faxed report sent to one of the alternate numbers explaining the problem you are experiencing; or call our Elections Division at 614-466-2585 to report the difficulty.

If there is a problem with your fax machine, you must telephone your results to our office. You must call 614-466-2586 or 614-466-2587 to report your results. The telephone operators will be recording results on the election night report forms. Operators will ask for your county name, number of precincts reporting, will read the office and the candidate's last name to you and record your results for each candidate.
